Dear Neighbour

It has been a very busy year on site at One Nine Elms. Since starting in February 2014, demolition works have been going well and we are looking forward to progressing with the next phase of the development in 2015.

Update on Completed Works

- The demolition of both towers reached level 16 in early October. Demolition has continued simultaneously on both towers and by the middle of November demolition works had progressed to level 12
- The tower crane has been lowered to its final level and will be dismantled over the 11th and 12th December 2014
- An additional crane has been put in place to facilitate project logistics
- For works to continue on darker evenings, additional lighting has been installed; this has been designed to minimise any light pollution for local residents
- Survey works have been undertaken on the basement in preparation for the construction phase

Upcoming Works

- Demolition will continue on both towers, on average a floor is demolished each week and is currently planned to be complete at the end of February 2015
- As the works get closer to ground level McGee are making every effort to avoid breaking and percussive demolition wherever possible
- Preparation is underway for the construction phase with enabling works for the piling taking place

Christmas working hours

The final day of works before Christmas will be Friday 19th December 2014. The site will be closed until Monday 5th January 2015.

Monitoring

Vibration, dust and noise levels continue to be frequently checked. Munching is used wherever possible throughout the demolition process to reduce noise and disturbance for our neighbours and the DOKA screens help to reduce noise levels at the point of demolition by 20-21dB.

In response to a request from our neighbours at St. George Wharf, McGee have also voluntarily agreed not to start noisy works on Saturdays until after 9am. We are committed to working with our neighbours throughout the demolition and construction process to reduce noise and disturbance.
